**Board of Directors Meetings**

Board of Directors meetings are from 7-9 a.m. at the Quora Education Center (70 W. County Road B2, Little Canada, MN, 55117). The AMSD Board consists of the superintendent and one school board member from each member district. Each director on the board is entitled to one vote. All school board members and district staff from member districts are welcome to attend AMSD Board of Directors meetings as guests. A hot breakfast is served starting at 7 a.m. From 7-7:30 a.m. is generally reserved for networking and socializing with other AMSD members. The business meeting begins at 7:30 a.m. In addition to routine business and action items, the agenda usually includes a guest speaker. An option to participate remotely via Zoom is available and the link is provided prior to each meeting.

**Committee Meetings**

Executive and Legislative Committee members are elected by the Board to serve 3-year terms. Committee meetings are from 7:30-9 a.m. in the Anderson Center at Bethel University (2 Pine Tree Drive, Arden Hills, MN, 55112). A continental breakfast is served. The executive committee meeting begins promptly at 7:30 a.m. and is generally brief. The legislative committee convenes immediately following the adjournment of the executive committee.
